

Privacy Policy

By using this web site, www.monetarywonderland.com, including its associated E-mail addresses, associated blogs (collectively "the Site") or information, text, data, graphics, software, and other contents (collectively "the Content") that make up the Site, any user (collectively "Users") of the Site acknowledges and agrees to the terms of use (the Term) and this privacy policy set forth herewith on the Site. The owner of the Site (the site owner) reserves the right to change the Term and the privacy policy without any advance notice. If Users do not agree with the Term and the privacy policy, Users may not use the Site and the Content.

This Privacy Policy governs the manner in which the Site collects, uses, maintains and discloses information collected from Users of the Site. This privacy policy together with the Terms of Use ("the Term") apply to the Site and all conducts through it.

Personal identification information

The Site may collect personal identification information from Users in several ways, including, but not limited to, when Users visit the Site, register on the Site, and fill out a form in the Site. Users may be asked for, as appropriate, name, email address. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personal identification information, except that it may prevent them from engaging in certain activities associated with the Site.

Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with the Site. Non-personal identification information may include the browser name, the type of computer and technical information about Users means of connection to the Site, such as the operating system and the Internet service providers utilized and other similar information.

Web browser cookies

The Site may use "cookies" to enhance User experience. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. Users may choose to set their web browser to refuse cookies, or to alert Users when cookies are being sent. If Users do so, Users should note that some parts of the Site may not function properly.

How we use collected information

Reversalpoint.com collects and uses Users personal information for the following purposes:

- EXEMPTION CLAUSE 1: To reflect comments from users on the Content, the Site, and the site owner: If Users send whatever opinion and information to the Site and/or to the site owner with respect to and relevant to the Content and any relevant topic for the Content, the Site, and the site owner, it becomes property of the Site and the site

owner. - EXEMPTION CLAUSE 2: If a user violates the Term, we may identify the user based on the information submitted by the user and make our discretionary attempt to block any future use by the user. In such case, we might use the personal information to notify the user about our enforcement measure.
- To improve user experience: We may use information in the aggregate to understand how our Users as a group use the services and resources provided on our Site.
- To improve our Site: We may attempt to improve our website contents based on the information and feedback we receive from Users.
- To administer a content, survey or other Site feature: To send Users information they agreed to receive about topics we think will be of interest to them.
- To send emails: The email address Users provide will only be used to respond to their inquiries, and/or other requests or questions.

The level of security in place & disclaimer.

The Site is operated based on the platform provided by "Weebly Pro". Given the fact that at this stage the Site does not conduct any direct e-Commerce activity, the level of security is within the scope of the platform specification and is not enhanced by any other additional security measure. In any event that could compromise or breach the security built in the platform, the Site and the site owner have no responsibility whatever the causes of such events and whatever the consequences are. Users may use their own discretion in providing personal identification information to the Site and the site owner.
